


INSTALLATION INSTRUCTIONS

Thank you for choosing Ambassador Marine.

Your new Ambassador Marine faucet, sprayer, shower or accessory will give you years of trouble-free performance. Please read these instructions carefully before installing your new item. If you have any additional questions about the installation of this product, please feel free to contact one of our friendly customer service representatives at 800.270.4262.





- 1) Set the flange with the foam gasket and screw in the drain hole in the sink. NOTE: The foam gasket is supplied for your convenience, however, we recommend using plumber's putty (not included) instead of the foam gasket. Do not use both the foam gasket and plumber's putty.
- 2) From under the sink, line up the drain body and the raiser with the thick rubber gasket inside with the flange and screw.
- 3) From above the sink, tighten the screw into the metal receiver inside the body.
- 4) Remove the protective sticker from the polished surface of the Stopper.
- 5) Screw 1 $^{1}/_{4}$ " drain pipe or adapter (not included) onto the body. Use Teflon tape (not included) on the threads to prevent leaks.
- 6) **OPTIONAL-** Drill a 3/16" hole in the counter-top or other surface and secure the stopper screw using the stopper nut, where desired. If you choose not to secure the stopper screw, you may remove the stopper chain (and stopper screw) from the stopper. Spread the ends of the stopper triangle connector and remove it from the stopper.

This warranty will not apply to faucets or accessories that were improperly installed, misapplied, or incompatible with components not manufactured by Ambassador. Faucet failures due to foreign debris is not covered under the terms of this limited warranty. Ambassador will not warrant any faucet or accessory that is physically damaged, or altered outside the Ambassador factory.

Returns are to be shipped postage prepaid to Ambassador Marine's service center at: 1173 Calle Suerte, Camarillo, CA 93012.

A Return Authorization Number is required and must be clearly visible on the the shipping carton.

Absolutely no credit or payment will be allowed for consumers on any item deemed defective. Ambassador Marine's obligation is limited to the repair or replacement of the defective item only, at Ambassador Marine's sole discretion. All returns will be examined and/or tested under Ambassador Marine test criteria. Replacements will be shipped freight prepaid.

This limited warranty is in lieu of all other warranties, expressed or implied, and no other person is authorized to give any other warranty or assume obligation or liability on Ambassador Marine's behalf. Ambassador Marine shall not be liable for any labor, damages, or other expenses, nor shall Ambassador Marine be liable for any indirect, incidental or consequential damages of any kind incurred by the use or sale of any defective product.
